

This is a profile of Burghfield Ward. It is intended to accompany the wider Joint Strategic Needs Assessment of West Berkshire. Profiles have been created for each of the Electoral Wards within West Berkshire.

The profiles are split into nine topics with these being accompanied by a summary of key findings and supported by metadata (information about the data used within the profiles).

The profiles are a tool which will be regularly developed with both improved functionality and also new and refreshed indicator data. We welcome your comments and suggestions so that we can ensure future developments are relevant and useful to you.

The profiles are in the main based only on data that are collected nationally with a high degree of completeness. This has been supplemented with local data where this has been considered appropriate.

Some indicators may give small numbers at Ward level. This should be taken into consideration when interpreting the data. Small changes in counts can lead to wide variance in the rate, and counts can vary significantly from year to year.

Any provisional conclusions drawn from the profiles should be compared with other sources of information, both quantitative and qualitative.

1. SUMMARY

- There are 5,923 people living in Burghfield 21.8% of these are children aged 0 to 15 and 16.6% are older people aged 65 and over. The non-white British population accounts for 7.07% of the total population. 93% of the Burghfield population were born in the UK. This is more than the average of West Berkshire.
- Out of the 30 wards in West Berkshire, Burghfield is the eighth least deprived ward. 9.7% of children in Burghfield are at risk of living in poverty, compared with 10% across West Berkshire.
- In Burghfield 5.8% of the working age population claim benefits compared with 6.3% in West Berkshire 71.6% of the population of Burghfield who are aged 16 to 74 years are in employment. This is higher than the average in West Berkshire. In Burghfield, the majority of people in employment (56% of workers) were employed in managerial/professional/technical occupations. 23% of workers were employed in professional occupations. 13.5% of working age people in Burghfield have no formal qualifications.
- 61.5% of children living in West Berkshire achieved 5 GCSEs at grade A* to C. 76.4% of children living in Burghfield achieved 5 GCSEs at grade A* to C. 67.4% of children living in West Berkshire achieved the expected level of attainment at Key Stage 2. 70.7% of children living in Burghfield achieved the expected level of attainment at Key Stage 2.
- The average life expectancy at birth for males living in Burghfield is 81.1 years. The average life expectancy at birth for females in Burghfield is 82.6 years. Death rates from all causes in people aged less than 75 are lower than expected. Emergency hospital admissions for all causes are lower than expected*.
- An estimated 21.3% of adults in Burghfield are obese. An estimated 19.3% of adults in Burghfield binge drink. An estimated 32.4% of adults in Burghfield eat healthily.
- There are a total of 2341 dwellings in Burghfield. The most common housing type in Burghfield is detached. This accounts for 50.9% of all housing. The average household size in Burghfield is 2.6 people and 2% of housing in Burghfield is classifed as needing one or more bedrooms more than it has in order to be adequately sized for the number of people living there.
- There were 283 crimes recorded in Burghfield during 2013/14. This equates to 47.6 crimes per 1,000 people living in Burghfield, a rate that is higher than the average across West Berkshire.
- In Burghfield, according to the urban/rural classification from ONS in 2012, 62% of the population live in areas classified as rural town and fringe, 38% of the population live in areas classified as rural village and dispersed.

How to read the spine chart:


The shapes on the graph represent the value of the ward compared against the Local Authority average. If positioned to the right of the average line this suggests the ward is performing 'better' in a particular indicator, to the left suggests it is 'worse'. This does not necessarily mean higher or lower values, e.g. high GCSE attainment is 'better', whereas a high crime rate is 'worse'. The light grey rectangle represents the range between the 'best' and 'worst' wards in the local authority. The yellow circles represent values that are within the 75th and 25th percentile for that indicator, or where most values typically lie. The black triangles represent values that are better than the average, whilst the blue diamond shows values that are worse.

Population Summary 2016

- Burghfield has a population of 5,923. This figure has increased at a slower rate than it has on average across West Berkshire since 2001.
- The working age population is relatively small in comparison to West Berkshire.
- Related to this, the ward has a proportionately larger young population (22%) and a smaller older population (17%).
- The 2011 Census indicates that 7% of Burghfield are BME, which is lower than the West Berkshire average.
- The largest single BME population is the 'White: Other' group. This group represents 31% of BME people and 2.2% of the total population of the ward.



Fertility Rate

Understanding the demography of an area will help with planning of appropriate services. The fertility rate is the ratio of live births in an area to the population of that area; expressed per 1000 population per year.


- The fertility rate, per 1,000 female population aged 15-44, in West Berkshire is 64.5, which is similar to the national rate of 63.6.
- The fertility rate in Burghfield is 70.2 per 1,000 female population aged 15-44, this is more than the West Berkshire rate.



New Births

Local authorities are key user of birth statistics. Data are used, for example, to plan maternity services, inform policy decisions and monitor child mortality.


- There were 1,721 live births in West Berkshire in 2015.
- 1051 of those were to mothers who reside in Burghfield.
- 57% were boys and 43% were girls.
- 70% were born within a marriage/civil partnership and 30% were born outside a marriage/civil partnership.
- 96% were born in an NHS hospital.
- The average age of mother at birth of child was 32.
- 91% of births were to mothers born in the UK.



Migration

- 93% of the Burghfield population were born in the UK. This is more than the average of West Berkshire.
- The majority of people living in Burghfield who were not born in the UK have been resident in the UK for 10 years or more.
- The majority of people living in Burghfield who were not born in the UK moved to the UK when they were aged between 0 to 4.


Length of time in UK (non-UK born residents)

3. DEPRIVATION, POVERTY AND ACCESS TO SERVICES

Indices of Multiple Deprivation (IMD)

- Out of the 30 wards in West Berkshire, Burghfield is the eighth least deprived ward.
- There aren't any people in the ward who are living in an area classed amongst the 10% most deprived in West Berkshire, according to the latest Indices of Deprivation.
- Nationally, there aren't any people in any of the wards of West Berkshire that are in the 10% most deprived areas when comparing them at an England level.

Child Poverty

- 9.7% of children in Burghfield are at risk of living in poverty, compared with 10% across West Berkshire.
- This figure has risen by 2.9% since 2006, and West Berkshire has increased by 0.5% since 2006.

Free school meals

 7.8% of children living in West Berkshire and attending schools in West Berkshire are eligible for and receiving free school meals. Free school meals data is not available for Burghfield Ward.


Accessibility

- Local bus services are provided by Reading Buses.
- The nearest train station to Burghfield is Theale train station.


Access to Services

- There are 178 households in Burghfield who do not own a car or van. This is 7.8% of all households in the Ward which is fewer than the West Berkshire average.
- The indices of multiple deprivation includes a measure of barriers to housing and services. On this measure Burghfield is the fifteenth least deprived ward in West Berkshire (out of the 30 wards).
- There aren't any people in the ward who are living in an area classed amongst the 10% most deprived in West Berkshire, against the barriers to housing and services measure.
- Nationally, there aren't any people in the ward who live in an area classed amongst the 10% most deprived for barriers to housing and services, according to the latest Indices of Deprivation.


Qualifications

Recent statistics on qualifications are available at ward level using data collected as part of the 2011 Census. This showed that:

- 13.5% of working age people in Burghfield have no formal qualifications.
- 51% were qualified to NVQ Level 3 or higher compared with 44.3% in West Berkshire as a whole.
- Please see the 'Education' section of these Ward Profiles for information on school attainment.

Employment

- In Burghfield, the majority of people in employment (56% of workers) were employed in managerial/professional/technical occupations. 23% of workers were employed in professional occupations.
- In West Berkshire as a whole the majority of people in employment (48% of workers) were employed in managerial/professional/technical occupations. 20% of workers were employed in professional occupations.
- 71.6% of the population of Burghfield who are aged 16 to 74 years are in employment. This is higher than the average in West Berkshire.
- 2.6% of the population of Burghfield who are aged 16 to 74 years are unemployed. This is lower than the average in West Berkshire.



5. EDUCATION

We have to treat the following data with some caution due to the small numbers that are involved in the calculations. It is likely that differences between areas will be largely due to random effects occurring within the data. Data has been aggregated to Ward level using data at a lower level of geography. Figures of less than three have been removed from this lower-level data meaning that it has not been possible to include them in the Ward-level totals. This is likely to affect the completeness of the Ward-level data shown. Where all data for a Ward have been removed from the original data it has not been possible to show a figure below.

Foundation Stage

 64% of children living in West Berkshire achieved the expected level of development in foundation stage. 77.8% of children living in Burghfield achieved the expected level of development in foundation stage.



Schools

 There are four schools located in Burghfield: Burghfield St Mary's C.E. Primary School, Garland Junior School, Mrs Bland's Infant School and The Willink Secondary School.

6. HEALTH

It is often difficult to use health data when looking at small areas such as Wards. This is because of the size of the numbers involved. For example, only a few people from each Ward may be admitted to hospital each year for a specific condition. When we are looking at numbers that are very small we have to consider two key points before they are used in profiles such as this. Firstly, when numbers are small we are not legally able to share them as the individual may be identifiable from the data. Secondly, it is difficult to come to any reliable conclusions from information which is based on these small numbers. It may also be the case that the information is not available at these low levels. This is particularly true of information about peoples lifestyles (for example, how many people smoke or drink alcohol). One of the ways that this is overcome is to use 'modelled' data. This is data that has been taken from a much larger number of people and used to estimate the likelihood of a certain characteristic appearing in other areas such as Wards depending on some key features of that area such as how many people of a particular age group live there.

Health data 2011-16

- The percentage of live births to mothers living in Burghfield which were
 of a low birth weight is estimated to be 2.6%. The percentage on
 average across West Berkshire is 2.2%. Any difference is statistically
 significant.
- The number of people living in Burghfield who are diagnosed with cancer is as expected given the age and gender structure of the population.
- The average life expectancy at birth for males living in Burghfield is 81.1 years. The average life expectancy at birth for females in Burghfield is 82.6 years.

6. HEALTH

Childhood Obesity

- The heights and weights of children in reception year and year 6 are measured annually as part of the National Child Measurement Programme.
- 7.9% of reception year children in Burghfield are obese. An average of 7% of reception year children in West Berkshire are obese.
- 10.4% of year six children in Burghfield are obese. An average of 14.4% of year six children in West Berkshire are obese.
- It is important to note that this data at Ward level involves small numbers and any differences between areas will be, in part, due to chance occurances in the data.


Adult Lifestyles

- An estimated 21.3% of adults in Burghfield are obese.
- An estimated 19.3% of adults in Burghfield binge drink.
- An estimated 32.4% of adults in Burghfield eat healthily.

Sense of health and wellbeing

- According to the 2011 Census 87.41% of adults in Burghfield feel that they are in either good or very good health.
- 5.2% of adults in Burghfield feel that their lives are limited a lot due to ill health or disability and 7.4% of adults in Burghfield feel that their lives are limited a little due to ill health or disability.

6. HEALTH

Falls are the largest cause of emergency hospital admissions for older people, and significantly impact on long term outcomes, e.g. being a major precipitant of people moving from their own home to long-term nursing or residential care. The tables below show falls related admissions broken down by local authority and electoral ward.




- The highest risk of falls is in those aged 65 and above and it is estimated that about 30% people (2.5 million) aged 65 and above living at home and about 50% of people aged 80 and above living at home or in residential care will experience an episode of fall at least once a year.
- Falls that results in injury can be very serious approximately 1 in 20 older people living in the community experience a fracture or need hospitalisation after a fall. Falls and fractures in those aged 65 and above account for over 4 million bed days per year in England alone, at an estimated cost of £2 billion.

7. HOUSING

- The most common council tax band in which housing in West Berkshire falls is Band C. This accounts for 28.5% of all dwellings. The most common council tax band in which housing in Burghfield falls is Band E. This accounts for 29.7% of all dwellings.
- There are a total of 2341 dwellings in Burghfield. 0% of these are shared dwellings. This is fewer than the average number of shared dwellings across West Berkshire.
- The most common housing type in Burghfield is detached. This accounts for 50.9% of all housing.




- The average household size in Burghfield is 2.6 people, which is larger than the average for West Berkshire.
- The average number of rooms in houses in Burghfield is 6.4. This is more than the average for West Berkshire.
- The average number of bedrooms in houses in Burghfield is 3.2, which is more than the average for West Berkshire.
- 2% of housing in Burghfield is classifed as needing one or more bedrooms more than it has in order to be adequately sized for the number of people living there.
 This is fewer households than the West Berkshire average.
- 1.4% of houses in Burghfield do not have central heating. This is fewer than the average for West Berkshire.



8. COMMUNITY SAFETY

- There were 283 crimes recorded in Burghfield during 2013/14. This equates to 47.6 crimes per 1,000 people living in Burghfield, a rate that is higher than the average across West Berkshire.
- The most commonly occuring crime was classified as Theft and handling stolen goods for which there were 14.8 crimes per 1,000 people living in Burghfield.



9. ENVIRONMENT

Area


- In Burghfield, according to the urban/rural classification from ONS in 2012, 62% of the population live in areas classified as rural town and fringe, 38% of the population live in areas classified as rural village
- Burghfield has an area of 17 square kilometers which represents 2% of the total area of West Berkshire.

Population Density

- Population density describes the average number of people living in each square kilometre of land in an area.
- There are an average of 346 people living in each square kilometre of Burghfield and an average of 36,161 people living in each square kilometer of West Berkshire.

Land Use

 The most common land use in West Berkshire is Farmland (fields, orchards etc), followed by Natural (moors, heathland, natural grassland etc), Built on (roads, buildings etc), then Green urban (parks, gardens, golf courses, sports pitches etc).
