PERMITTED DIMENSIONS:

Headstones: The overall height must not exceed 760mm, standing on a base not exceeding 760mm wide by 460mm deep. The single sub-base/foundation must be underground and must not exceed 910m wide by 460mm by 76mm high.

Cremation Tablets: The memorial stone must be a desktop tablet design and must not exceed 457 mm (18 inches) in length, 380mm (15 inches) in width and 228mm (9 inches) in height reducing to 76mm (3 inches) at the thinner end. The single sub-base foundation must be underground and must not exceed 430mm square by 50mm high.
